All Members are required to abide by the rules, regulations, and by-laws of the Clinton Country Club. All dues will be set annually by the Board of Directors. All new membership applications must be approved by the Board of Directors.

DUAL MEMBERSHIP: You may play an unlimited number of rounds, with no minimums, for only \$399 for a single membership or \$550 for a family membership for the year. Must provide proof from your home course that confirms you hold a current full golf membership. Cart not included.

Payment of Dues & Minimums at Bar & Restaurant

Dues are due in full by January 31st or they may be paid in 9 monthly installments from Jan- Sept. with the payment due at the end of each month. 10% interest is charged for monthly payments, with a \$10 late fee if paid after the 10th of the month following the payment due date. For a Single Golf membership w/certificate, the monthly payment is \$168.25, for the Full Family membership w/certificate the payment is \$231.47. *Young Adults may pay in three equal installments of \$184.00 payable on April 1st, May 1st, and June 1st. There is a 4% fee added if dues are paid by credit card.

There is a \$15.00 monthly minimum required of each adult member (out of high school) for eleven months (Feb-Dec) to be spent at the bar/restaurant, unless your home is 75 miles or more from the Club location.

Purchasing Certificates

Certificates are sold by share and each share has a face value of \$250.00. Each type of membership requires a different number of shares to participate fully in ownership. They are as follows: House Membership (1 share); House, Pool, & Tennis (2 shares); Single Golf (4 shares); Family Golf (8 shares). You may pay golf dues plus certificate costs on a monthly basis (12 payments) if the certificate is purchased from the club. Payment plans are available for 1-yr., 5-yr., and 10-yr. options on the certificate portion for golf memberships only. You may also purchase a certificate from a member owner, and for a \$10 fee it will be transferred into your name. The 2020 monthly payment for Single Golf dues and certificate are: 1 yr-\$225 per month; 5 yr-\$152; 10 yr-\$142. Monthly payments for Family golf dues and certificate are: 1 yr-\$367; 5 yr- \$220; & 10 yr - \$202.

As a certificate owner, you will be allowed to vote on all club issues as well as run and vote for the Board of Directors. These certificates are transferable to your beneficiary and can be sold on the open market as well.

NOTE: Because of an increased tax liability, your dues will be greater as a non-certificate holding member. To be charged the certificate owner rate, your certificate must be equal to or greater than the membership classification you are paying for.

Members may also receive \$100 for each new golf membership you sponsor. The \$100 can go to you as the sponsor or it can be applied to the new golf membership dues.

Golf Cart Policy:

Golf carts are available for lease through the Club or you may store you own in our cart shed. A cart shed space costs \$400.00 for the first year, then \$350.00 per year thereafter. Annual cart lease costs for a single membership are \$630, and for a family membership \$900.
