NOTE: Because of an increased tax liability, your dues will be greater as a non-certificate holding member. To be charged the certificate owner rate, your certificate must be equal or greater than the membership classification you are paying for.

STOCK CERTIFICATES

Each stock share has a face value of \$250.00. Each classification of membership requires a different number of shares to participate fully in ownership. They are as follows:

House Membership	1 share
House, Pool, Pickle Ball	2 shares
Single Golf	4 shares
Family Golf	8 shares

As a certificate owner, you will be allowed to vote on all club issues as well as run and vote for the Board of Directors. These certificates are transferable to your beneficiary and can be sold on the open market as well.

Often, there are certificates for sale by individuals posted on the club bulletin board, or you may purchase a certificate from the club. You may pay golf dues plus certificate cost on a monthly basis if the certificate is purchased from the club. Payment plans are available for 1-yr., 5-yr., and 10yr. options.

DUES MAY BE PAID IN INSTALLMENTS

Dues are payable in full by January 31st or they may be paid in monthly installments, with the payment due by the end of each month. As the year progresses, divide your membership dues by months remaining in the year.

RESTAURANT POLICY

Each adult member is required to spend a minimum each month in the restaurant and bar of \$20.00, unless their home address is 75 miles or more from the Club location.

GOLF CART POLICY

Golf carts are available for lease through the club, or you may store your own in our cart shed. A cart shed space costs \$350.00 annually. We also offer the option to lease the use of a rental cart on an annual basis. The cost is \$630 for a single lease and \$900 for a family lease. This gives you the use of a cart whenever you're playing golf. The cart should be returned to the fleet upon completion of your round. *PLEASE NOTE: A single cart lease is for one cart/individual only. If you have a family membership and always ride together, a single lease is appropriate. If you have a family membership and more than one person needs to check out a cart, you must pay for a family cart lease.*

Each member who owns a golf cart will be required to either rent a cart shed space or shall be required to remove the golf cart daily from the club premises. Absolutely no golf carts will be allowed to remain on the premises overnight, except inside the golf cart storage facility. Trail fees will be charged for all carts not housed in the cart shed. No carts are allowed on the golf course except those belonging to the club or to members of the club, except for tournaments when specified.

PLEASE NOTE: *Our restaurant staff does a great job of helping prospective members with questions and paperwork and we appreciate them greatly. With that in mind, they are restaurant employees, not club employees and do not always have complete or updated information regarding membership. That is usually our fault, not theirs.
